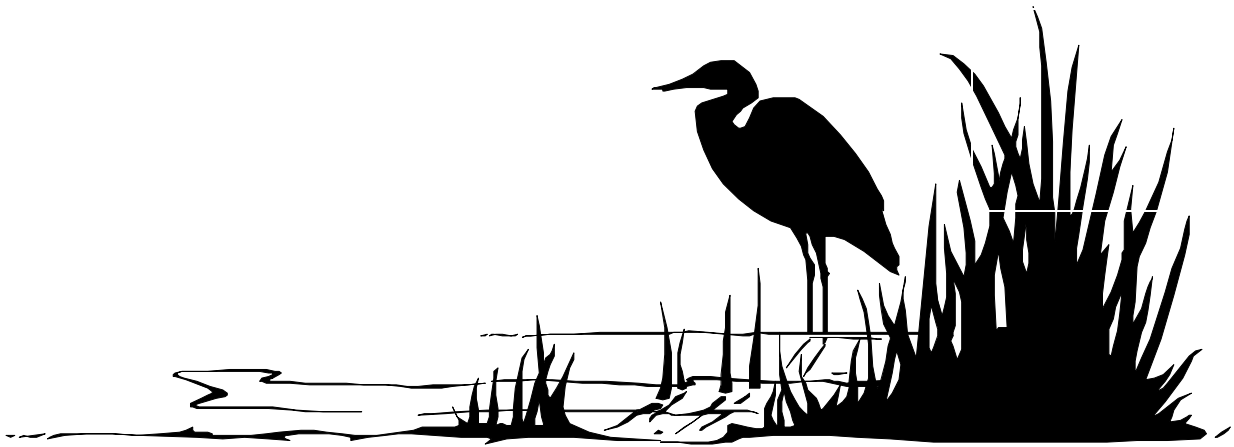
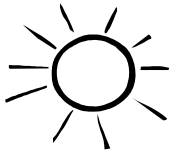

General Information

What

The Envirothon program is a competitive event for high school teams of five members to compete in a natural resources knowledge and ecology field day against other high school teams. It stimulates, reinforces and enhances student's interest in the environment and our state's natural resources. Resource subject areas are: Soils, Forestry, Wildlife, Aquatics, and Current Environmental Issues.

An entire school class or group may participate in studying the resources, however only 5 members may be on a team taking the test. Each team must have an advisor. Each class or school may have as many teams as they wish. However, each team will have to be registered.

There will be a resource station set up for each of the subject areas (Soils, Forestry,

Wildlife, Aquatics, and Current Environmental Issues), usually in an outside setting, where the teams will be given a written exam on each of the above resource subjects. The team with the highest score will be declared the Area/State winner and the state winner will be eligible to compete in the North American National Competition usually held in late July or early August in a different state each year.

The written test will last for 25-30 minutes and will have approximately 25 questions. These questions are answered as a team and not by individual students. After finishing one station and at a set time, the teams will rotate to the next station. The test papers are graded and the scores totaled to select the winner.

Test Stations

The five test stations will likely cover the following topics, but are not limited to these:

Wildlife.

Wildlife covers habitat, identification, foods, rules & regulations, diseases, and management.

Aquatics.

Aquatics covers ecology of water, stream improvement, water chemistry, water quality, plants and animals living in or around water, pollution, and conservation.

Forestry.

Forestry covers tree identification, improvement of timber stands, forest ecology, insects, diseases, forest management, and forest measurements.

Soils.

Soils covers classification, erosion, soil surveys, site suitability, current issues, profiles, soil characteristics, and conservation practices.

Current Environmental Issues.

Current Environmental Issues cover any current or newsworthy environmental issue.

Professionals from cooperating agencies and/or independent environmental organizations will do the station testing.

Who

Competition is open to Ecology clubs, Girl Scouts, Boy Scouts, soil- judging teams, 4-H clubs, home study groups, environmental groups, Vo-Ag groups, or any group interested in competing. Team members must be high school students (grades 9-12) and from the same school. An exception is made for home study groups, scout groups, 4-H teams being from the same school; however, they must be from the same general area. An advisor is required.

When

The State Competition is usually held in late April or early May. The 2010 competition is scheduled for April 23-24, at Cedarrock Park near Burlington, North Carolina.

Where

The State Envirothon will be held at Cedarrock Park in Alamance County. (See map on page 26)

Registration

Each of the eight Areas of the NC Association of Soil & Water Conservation Districts will have a structured registration program for the eight Area Envirothons. Your local Soil & Water Conservation District can assist you in registering your team for the Area Envirothon (see list of Districts included in back). There will be seven teams from each Area competition to advance to the State Envirothon Competition. The highest scoring FFA team must advance to the state competition, regardless of placing in the top seven teams. If your highest scoring FFA team does not make the top seven teams, then your Area may send the top seven teams plus the highest scoring FFA to make eight teams.

There is a \$50.00 participation fee for each of these seven/eight teams advancing to the State Competition. The FFA team must declare at registration if they are an FFA team or non-FFA team.

This \$50.00 participation fee is payable to the NC Association of Soil & Water Conservation Districts. Checks for high school teams should be mailed to Steve Bennett. Most of the time the local Soil & Water Conservation Districts will pay the participation fee.

Resource Information

Once a team has made contact with your local Soil & water Conservation District (see telephone numbers pages 21-24), a resource packet containing natural resource information will be sent to each advisor to use in preparing their team/teams for the competition. They can also assist the teams in securing additional information/resource people to help train the students. **Questions will come from the resource material or from materials presented at the training station on Friday.**

State Registration

Registration at the State Competition event will be from 1:00 P.M. to 2:30 P.M. on Friday and from 8:00 A.M. to 9:30 A.M. on Saturday. FFA teams must declare if their team is the official FFA team before or at time of registration.

Station training at State Envirothon

We have resource professionals to give a short training session at each station at the State Envirothon on Friday afternoon as part of a training program. These Presentations are not set up to give the answers to the students. We expect that they have studied prior to coming to the Envirothon. We ask the presenters to cover some of the material from where the questions come from but not to cover just the test. This is a good time for the teams to ask questions of the professionals if there is something that you do not understand.

We also tell them that if they have a question that is not in the resource material that we give you to study, that they can ask the question as long as they cover the material during their presentation on Friday.

Sponsor

We are asking that you secure the local Soil & Water Conservation District to sponsor your team. The sponsoring District may or may not be able to pay your participation fee. If for some reason the local District does not wish to sponsor your team, the State Envirothon Steering Committee will sponsor your team, but cannot pay the participation fee. A list of

Soil & Water Conservation Districts is included in this packet.

Team Size

Maximum team size to compete is five (5) members. If a team has less than five (5) members to show up, it will be allowed to participate. Schools may send more than one team to the Area competitions, however each team must pre-register separately (see pre-registration).

Awards

After lunch on Saturday, there is a brief awards program to announce the winners and recognize the financial contributors and important guests.

Awards are as follows:

First Place \$200.00 cash, plaque, and an expense paid trip to the National Competition

 \$500.00 scholarships (started in 2005, if there is enough money we will continue this.)

Second Place \$150.00 cash, and a plaque

Third Place \$100.00 cash, and a plaque

Fourth Place \$50.00 cash, and a plaque

Fifth Place \$25.00 cash, and a Plaque

Community Service Learning Project winner—Plaque

FFA Winner Plaque

Medallions will be awarded to each member of each team having the highest score at each of the five resource stations.

Grievance Policy

A Grievance Committee has been established to hear complaints about teams not following the rules, cheating, etc. Please inform your team members that if they wish to make a grievance or complaint, that this must be done as soon as possible and before the

winners are announced. The guides at the stations are available to take grievances. They should be written down by the guide to present to the Grievance Committee.

Alternate Members

Alternates are allowed to participate in the State Competition. Some of the Areas may/may not allow alternates to compete at the Area competition. Check with the Area Representatives to see if they are allowed. (See page 11)

Visitors

Visitors are welcome to come and observe the State Competition. Please contact Steve Bennett, Envirothon coordinator (919) 791-4307, so enough food can be prepared. All visitors will be given a visitors ribbon for identification. There will be a meal charge for visitors.

Meals

Two meals are provided during the competition, dinner on Friday evening and lunch on Saturday. Meals are usually quick foods and may include hot dogs, hamburgers, pizzas or cold cuts. If anyone cannot eat the meals provided or have special dietary needs, they should bring their own food and cooler to store it.

Parking

There will be a special area set aside for parking, and we will have someone directing traffic. Please park in the designated areas.

Certificates

Certificates will be prepared for each participating team at the state event. Please, send the names of all team members, spelled correctly, and the parental consent/medical information form as soon as possible when registering for the Area Competitions. The certificates at the State Competition will be presented the day of the competition or mailed later.

Motel Information

For those teams coming in Friday and are not camping, there is a list of motels in this guide. Because there are often other events that may compete for area motel rooms,

please make your reservations early. Reservations can always be cancelled later.

Camping

For this competition, Cedarock Park allows tent camping in designated areas. There may be a charge for camping this year. If your team wants to camp at the park contact Phil Ross, Alamance Soil & Water Conservation District at (336) 228-1753 or check at the registration desk when registering. Camping can be a great educational experience for the teams.

Teams Traveling Together

Some teams may want to car pool or van- pool in order to save on transportation costs. If you do and would like to have a contact person for other local teams, please contact your Area Envirothon contact.

Weather

The competition will be held outside regardless of the weather. **Bring appropriate clothing.** If it is warm and sunny, please consider sunscreen. There may also be early morning dew. Please bring rain gear if rain is possible.

Dress

Do not wear any item of clothing or anything else that may identify your team by city, county, or school.

First Aid

A registered nurse will be on site to handle emergencies. The nurse looks at the medical consent form to make sure that she has supplies for any needed medical problems before the competition begins. This is why it is important for the teams to send back their medical consent forms on time.

Envirothon Community Service learning Projects

We plan on having a voluntary Community Service Learning program for those high school and middle school teams wishing to participate. This program will involve a community service learning project.

The program will be voluntary to participate. Envirothon teams will design and develop a community type project and carry it out during the school year. It can be a **physical project** like an outdoor classroom, nature trail, wildlife habitat development, small pond, etc., a **service project** like a high school Envirothon team teaching middle school students about the environment, starting a recycling program in school, picking up litter along a stream, or a **data sharing project** like keeping data on a stream, pond as to water quality parameters such as DO, pH, macroinvertebrates found, putting this info on poster paper and presenting findings, researching or collecting data on storm water runoff and presenting information as to it's effects on water quality. The project has to be written up in a format with enough detail that a layman can understand what your missions and goals were. It can include graphs, pictures, posters, etc.

The team has to give at least a fifteen-minute presentation on the project to a public body or at a community meeting. Some examples are: Lions Club meeting, Rotary Club, County Commissioners meeting, Soil and Water Board meetings, etc.

The presentation has to be videotaped and sent to be judged by March 1, each year along with a write up of the project. Plaques will be given to the best ones during the awards program at the Awards Program at the State Envirothon. High School Envirothon Rules

1. Students in grades 9 through 12 are eligible to compete as a team.
2. All team members must be from the same high school unless they are a local home study group, scout group or 4-H group.
3. Each team will consist of no more than five members.
4. Teams must be accompanied by a team advisor and / or a Soil & Water Conservation District representative to the competition.
5. During the testing competition, the advisors may not travel with the teams and shall not assist their teams in any manner.
6. No electronic recording, no digital cameras, no taping and no picture taking on Friday afternoon during training sessions.
7. Advisors will be responsible to assure that teams display proper conduct during the competition and at the host facility.
8. Drugs and alcohol are NOT permitted during any part of the competition. (Rules applicable to the local area will be adhered to)
9. No clothing or other identification of local schools, towns, cities, or counties will be permitted.
10. All identification keys/ materials to be used during the test will be furnished by the State / Area Envirothon Committee.
11. The winning team will be the team with the highest cumulative point total. Certain questions will be pre-selected as tiebreakers. The tied teams will have their pre-selected questions compared until the tie is broken.
12. Rules & regulations of the Envirothon are subject to change. Any and all changes will be explained in advance to all teams and advisors.
13. No advisors or spectators allowed in testing areas on Saturday morning.
14. Alternates are allowed to participate in State High School Competition.
15. The judge's decisions are final on all events.
16. In the event that the winning team cannot represent the state at the National Competition, the team with the next highest score will be eligible to compete.
17. All grievances must be reported before final judging. The grievance committee will handle all grievances.
18. Advisors must send team's health forms and parental consent for picture taking to Area Envirothon Committee when you are registering for the Area event.
19. Each Area will submit the 7/8 registration forms with names of the team members from that Area eligible to compete at the state competition along with a copy of the medical consent forms to the State Envirothon Coordinator as soon as possible after the Area Competition.

20. All teams must participate at an Area competition and be one of seven top teams chosen to go to the state competition before competing in the state event. The highest scoring FFA team from each Area is also eligible to participate in the State Envirothon for the FFA Environmental Quality Competition, which could be an eighth team from some areas if the FFA team was not among the top seven teams.
21. Substitutions may be made on a team selected to go to the state competition, but there must be at least three original team members able to compete at the next level.
22. Violations of these rules can result in the disqualification of a team or a lesser penalty
